

Kurzeme Planning Region





Kurzeme is a unique region in the west of Latvia. It can be proud of the long and diverse coast of the Baltic Sea and important cultural and natural heritage. The widest waterfall in Europe – Ventas Rumba – is situated in the heart of Kurzeme. The landscape of the region keeps traces left not only by the Suiti and Livs, but also by the Vikings.

Historically, Kurzeme Region is known by its strong traditional economic sector (forestry, agriculture and fishery) and manufacturing industry. The development of technologies and creative industries also plays an increasing role. Ports are an important aspect in the development of the cities of national significance – Liepāja and Ventspils. Kurzeme has three regional development centres – Kuldīga, Saldus and Talsi, and each of them has its own special significance. Every year this region is visited by an increasing number of tourists, who want to visit Kurzeme, explore its special natural values, buy local craftsmen goods and farm products, enjoy the charm of the cities of Kurzeme during the city festivals and celebrations, and find peace on the beaches and nature trails.

The concept of sustainable development includes environmental, economic, social and governmental aspects. The Kurzeme Planning Region sustainable development strategy "Kurzeme 2030" is designed with the aim to balance these four aspects, to define the main directions of development, and to continue the work on the improvement of Kurzeme regional development and quality of life of the inhabitants. Implementation of the strategy will enhance cooperation both regionally and internationally, as well as it will promote investments in the development of education and technology.

Activity and Functions of the Region

Kurzeme Planning Region is one of the five planning regions in Latvia. The executive board of Kurzeme Planning Region is the Administration. The task of the Administration is to represent the interests of local governments of Kurzeme at national level.

The most important functions of the Administration

- Regional development planning, coordination and monitoring, including drafting of the spatial development planning documents of Kurzeme Planning Region.
- Ringing forward proposals for drafting of national and local development planning documents, coordination of drafting of the local development planning documents.
- Providing resolutions on compliance of sustainable development strategies and development programmes of local governments with development planning documents of the planning region and requirements of laws and regulations.
- Representation of the region's interests in ministries, commissions, committees and councils.
- Coordination of cooperation between regional authorities, state and local government institutions.
- Identification and preparation of regional projects for financing from various financial sources, implementation of the regional projects, and consulting municipalities on project preparation.

- ★ Drafting of Kurzeme Planning Region sector development documents.
- Provision of relevant information accessibility for Kurzeme Planning Region municipalities, businesses and citizens.
- Notification of Kurzeme Planning Region municipalities and entrepreneurs of opportunities to participate in projects and attract funding.
- * Entrepreneurship promotion.
- ★ Provision of public transport accessibility for inhabitants of the region.

Along with performance of its core functions, the region is also involved in other initiatives regarding tourism, environmental protection, social and other spheres, as well as it implements the cultural programme of Kurzeme Planning Region by funding various cultural events in the region. In the 2007–2013 planning period Kurzeme Planning Region attracted almost eight million euros, which were invested in the development of the region.



The main sectors – transport and logistics, wood processing, metal processing, agriculture, food and clothing production, fisheries, tourism

















The Region's Role in Latvia and the Baltic Region



Kurzeme Region is an important area both for Latvia and for other countries. Two of the three major Latvian ports are located in Kurzeme - in the Baltic Sea region development centres Liepāja and Ventspils. Both cities of national significance are included in the TEN-T network. The 350 km long Baltic Sea coast is considered as a resource of international importance, which is unique in the Baltic Sea area. Kuldiga Old town and Venta Rapid (Ventas rumba) and the Grobina Archaeological Complex are included in the Latvian National Register of the UNESCO World Heritage List, while the Suiti cultural space is included in the UNESCO list of Intangible Cultural Heritage in Need of Urgent Safeguarding.





Objectives and Priorities

Strategic objectives

Smart development – focused on **the change of thinking and behaviour**, which can be achieved by investments in education, science, creative industries, as well as by changing public environment and developing entrepreneurial thinking.

Attractive living environment – focused on the change of living and working environments, which can be achieved by purposeful changes in living and working environments and by focusing on location-oriented development.

Global connectedness and openness – focused on openness and the use of global opportunities by the region, place and individuals, which can be achieved by establishing cooperation-driven management.

Priorities

Knowledge – from formal education to skill-based lifelong education.

Initiative and responsibility – from profits at any cost to socially reasonable profit.

Supporting infrastructure – from infrastructure support in the sector to infrastructure support in a particular location.

"Vital" areas – from orientation to service to orientation to people/social orientation.

Employment – transition from a place at work to work in a particular place.

Energy resources and energy efficiency – from low resource processing to high resource processing, from energy consumption to energy saving – making more with fewer resources.

Cooperation and competitiveness – from competition to mutually beneficial cooperation.

Recognition – from local recognition to targeted local marketing.

Governance – from management to governance.

Potential resources – underground gas storage development and alternative energy development, oil extraction.



Spatial Development Perspective

Residential facilities and development centres


Approximately 280 000 inhabitants live in Kurzeme Region. The population density is 21 people/km² with explicit differences among the territories. The population is concentrated around the major cities (Liepāja, Ventspils, Kuldīga, Talsi, Saldus), creating residential locations with functional linkage.

Development centres in Kurzeme Planning Region:

- ★ Development centres of the Baltic Sea region/ national significance – Liepāja and Ventspils
- * Development centres of regional significance -Kuldīga, Saldus, Talsi
- * Development centres of municipal significance -Aizpute, Alsunga, Brocēni, Dundaga, Durbe, Ezere, Grobina, Mērsrags, Nīca, Pāvilosta, Piltene, Priekule, Roja, Rucava, Sabile, Skrunda, Stende, Ugāle, Vaiņode, Valdemārpils, Ventava
- ★ Development centres of local significance set in the municipality development planning documents

Natural and cultural area

- * Rural/agricultural and forest areas, specific coastal area, frontier area and urban areas are typical for Kurzeme.
- * A particular value is added by the cultural and historical areas that once were populated by the Suits, Livs and the Curonian Kings, as well as the cultural areas in Rucava, Bārta, Nīca and Abava. Kuldiga Old town and Venta Rapid (Ventas rumba) and the Grobina Archaeological Complex are included in the Latvian National Register of the UNESCO World Heritage List, while the Suiti cultural space is included in the UNESCO list of Intangible Cultural Heritage in Need of Urgent Safeguarding.
- ★ 14% of Kurzeme Region is covered by specially protected natural areas (more than the average number elsewhere in Latvia). Slītere National Park is situated in the northern part of Kurzeme. Besides, there are various protected areas located in river valleys, near lakes, in forests, on the coast, and in the sea. Every year cultural and natural monuments attract many tourists to Kurzeme Region.







Accessibility of the locations and infrastructure Kurzeme energy infrastructure:

- 110 kV and 330 kV power lines, construction of a new 330 kV power line is planned ("Kurzeme Ring")
- natural gas pipeline in the south of Kurzeme, construction of a new gas pipeline connected to Ventspils is planned
- ★ oil product pipeline Polotsk–Ventspils
- ** potentially developed sectors wind, solar, geothermal energy extraction, use of wood and waste recycling for energy extraction

Kurzeme transport infrastructure:

- multi-modal transport corridors Riga–Liepāja (Southern corridor) and the Riga–Ventspils (Northern corridor) with the state major road network, railways, two major ports and airports
- ** potential for rail passenger services by Nothern and Sothern corridors
- ★ development of the Mid-Kurzeme Corridor (Tukums–Kuldīga)
- * regional motor roads connecting cities of national significance and of regional significance
- * small ports Mērsrags, Roja, Pāvilosta
- * passenger transportation in the region is provided by the public bus network and private transport
- construction of international cycling routes EuroVelo 10 and EuroVelo 13 is planned






















